SUBJECT : MUTUAL AID BENEFIT FOR COVID-AFFECTED PHYSICIANS

To claim the **disability benefit**, please submit a photocopy of a positive COVID-19 test or current condition of the member through a medical certificate from the attending physician.

To claim for **death benefit**, please provide a copy of death certificate and details of the beneficiary.
