### To all Chapter Presidents, Subspecialty Society Presidents, Cluster Heads, and Department Chairs,


The Memorandum of Agreement (MOA) between our Society, the **Philippine Pediatric Society, Inc. (PPS)** and the **Philippine Association of Health Management Organization Companies (PAHMOC)** has finally been signed with effectivity period from 1<sup>st</sup> of September 2021 to the 31<sup>st</sup> of August, 2023.

In this connection, may we request you to cascade the information to your respective members/staff. Processing priority shall be given to those who are already member-participants in the PPS-AHMOPI MOA. This being the case, their enrolment will be fast-tracked. You may submit the list of those earlier accredited in the other HMO group who are interested to expand participation to PAHMOC-HMOs.


You may submit their information sheets even in batches at a later time. Those applying for the first time shall follow the procedures to be detailed in "The Orientation" to be provided in the website. ALL applications are to be submitted through your Office. No individual application is to be processed at the PPS National Office. The application process and the PAHMOC-PPS MOA shall be posted in the PPS website by the 15<sup>th</sup> of September, 2021 and can be accessed through the following: <https://pps.org.ph> → Council and Committees → Council on Administrative Affairs → Committee on Professional Health Care.
