The Nominee must be a FELLOW/EMERITUS FELLOW OF PPS in good standing. He/she must be in active pediatric practice for at least 10 years prior to the nomination and of good moral character.

The Nominee may be nominated by a PPS member, a chapter or a HAB accredited training institution through a nomination letter.

The Nominee will submit an affirmation letter from the Department Chair and Hospital Director stating exemplary clinical practice as evidenced by ethical, moral, legal and professional conduct.

The Nominee will be rated based on the following criteria: As a clinician, an educator, a leader/manager, a researcher, and a social advocate.
