To: PPS members with existing contract with any PAHMOC HMO-member

Please be informed that as per letter sent by the President of the Philippine Association of Health Maintenance Organization Companies, Inc. (PAHMOC), Mr. Christian Argos, to the Philippine Pediatric Society President, Dr Joselyn A. Eusebio, PAHMOC will be granting an increase in their currently contracted fees for the period of September 1-30, 2021. The said letter reads:

"Cognizant of the present COVID 19 pandemic situation, the PAHMOC members have reached an agreement to increase the PF (professional fees) of all HMO-affiliated doctors by 50% based on contracted rates up to a maximum of Php 600.00. This PF shall apply to all face-to-face Outpatient consults, regardless if the case is Covid or non-Covid. This likewise takes into consideration the use of Personal Protective Equipment, cost of disinfection, and other necessary infrastructure innovations. For HMOs engaging in Telemedicine, the maximum PF rate for Telemedicine consult is Php 400. This will be effective from September 01-30, 2021 or if the pandemic declaration is lifted, whichever comes first.

We share the same mission with the government to promote a healthy and safe environment, and we applaud all our frontliners for heeding its call. It is with the same objective that we are also responding to the COVID crisis that has brought forth huge challenges to the healthcare industry. All the same, as members of PAHMOC"
