ANNOUNCEMENT REGARDING ELECTIONS FOR PPS-BOT 2020-2022

The year 2020 is an election year for the Philippine Pediatric Society Inc. However, with the cancellation of the 57^{th} Annual Convention in April 2020 where elections are traditionally held on the 2^{nd} day of the Annual Convention, this will NOT push through this year.

After consultation with our corporate lawyer and based on the Revised Corporation Code or Republic Act No. 11232 Section 23 which states that "in the election of trustees, members may also vote through remote communication when so authorized in the by-laws OR by a majority of the Board of Trustees" the incumbent PPS-Board of Trustees suggests ON-LINE elections for the selection of the members of the PPS-BOT 2020-2022.

To ensure the successful conduct of this proposed method, the incumbent PPS-BOT recommends the following:

- 1. Conduct a nationwide survey among PPS members to determine if online elections are acceptable;
- 2. Conduct random mock elections to guarantee the accuracy and credibility of this proposed voting exercise.
