THE VOTERS

- For the 2020 election, the following members are qualified to vote:
 - A. Members in good standing as of April 30, 2019 even with outstanding annual dues for 2019, and
 - B. Members who became such in April and December 2019 even with outstanding annual dues

PROXY VOTING

GUIDELINES

1. The Philippine Pediatrics Society (hereinafter referred to as “PPS”) will hold its annual elections on June 30, 2020, from 8:00 a.m. To 3:00 p.m.
2. Members may exercise their right to vote through a proxy, as authorized in the by-laws.

PROXY VOTING

3. Members opting to vote through a proxy must submit a written notice or letter of authorization indicating therein the following:
 - Member's name;
 - Name of assigned proxy;
 - Signed and dated by the member indicating the place of signing.

4. The assigned proxy need not be a lawyer. The written notice or letter of authorization need not be notarized.

PROXY VOTING


5. The written notice or letter of authorization must be sent to the Secretary of the PPS by June 15, 2020.
6. Members voting through proxy must be noted by the Secretary of the PPS.


MOCK ELECTIONS

- Will be held on June 23, 2020
- It will simulate the actual elections
- Dummy candidates will be utilized using names of national heroes

VOTING PROCESS

- Proxy voting is allowed
- The voting process will start by using the PRC number as default login
 - Users must check their chapter and input their cellphone numbers or e-mail address and the computer will send a one-time PIN (OTP) to the said e-mail.

- The voters shall be required to vote for eleven (11) trustees viz eight (8) members from candidates at large and three (3) members representing Luzon, Visayas and Mindanao, respectively.
 - Choose and vote by clicking the name of the candidate listed in alphabetical order.

- Check if the summary page contains eleven (11) votes to be accepted and deemed valid.
 - To end, click the “submit ballot” button on the screen and log out.
