ANNOUNCEMENT PPS-AHMOPI Member Enrollment

The Committee on Professional Health Care received with appreciation the positive response we received from our HMO Group-Partner, Association of Health Maintenance Organization of the Philippines, Inc. (AHMOPI) on our persistent request to simplify the application of the PPS membership into the 2024-2026 Memorandum of Agreement (MOA).

Herewith is the process of enrollment into the PPS-AHMOPI MOA 2024-2026:

A. **Members who were accredited under the expired PPS-AHMOPI MOA 2021-2023** must inform PPS of their intention to continue with the MOA program thru their respective PPS Chapter Presidents, NCR Cluster Heads, or Department Chairs, as may be applicable. They have to simply sign PPS-AHMOPI Form 2 (Revised March 2024). Note that the revised Form 2 has a compliance action as required by the Data Privacy Law. This signed form, together with the signatures of other similarly intentioned members in the Chapter, NCR Cluster, or Department will then be forwarded with a certification (PPS-AHMOPI Form 1) by the respective heads to PPS. PPS will then issue the final certification to AHMOPI. They do not need to do anything else.

B. **Member who are just new applicants will have to do the following:**

B.1 Inform PPS of their intention to be part of the 2024-2026 MOA program. This should be done thru their respective PPS Chapter Presidents, NCR Cluster Heads, or Department Chairs, as may be applicable. They have to sign PPS-AHMOPI Forms 2 (Revised March 2024). Note that the revised Form has a compliance action as required by the Data Privacy Law This signed form, together with the signatures of other similarly intentioned members in the Chapter, NCR Cluster, or Department **and** the individual PPS-AHMOPI application forms will then be forwarded with a certification (PPS-AHMOPI Form 1) by the respective heads to PPS. PPS will then issue the final certification on both their intent and their PPS membership. to AHMOPI **B.2 Accomplish and submit the PPS-AHMOPI application Form.**

Fill up and submit the individual PPS-AHMOPI Application Form to their respective Chapter Presidents, NCR Cluster Heads, or Department Chairs.

B.2 Accomplish and submit the PPS-AHMOPI application Form.


Fill up and submit the individual PPS-AHMOPI Application Form to their respective Chapter Presidents, NCR Cluster Heads, or Department Chairs.
